SHORT TERM FUNDS_

We make it easy for you to focus on your mission with meaningful investment management, timely report delivery, and simplified online access. We align your goals with the mission of the church – building congregations for generations to come.

MONEY MARKET FUND

A money market fund is an investment fund that typically invests in short-term, low-risk securities like Treasury bills, commercial paper, and certificates of deposit. Money market funds are typically used as a way to place cash and earn some interest while maintaining liquidity.

CD FUND

A CD is a time deposit typically used as a way to save money for a fixed period at a fixed interest rate. CDs are often chosen by individuals and organizations who want to save money and earn a guaranteed interest rate over a specified term.*

OPEN A NEW ACCOUNT

Note: CD coupon rates change weekly. Your rate will be within the range provided. Actual rate will be provided at the time of purchase. UMF's default will be to reinvest your CD at maturity unless you direct us to do otherwise within the agreement or at least two (2) weeks prior to maturity. The CD Fund is considered a short-term investment option. As such, CDs can only be opened with revocable and available funds. *CD interest is guaranteed at full maturity. Par (face) value cannot be guaranteed with early withdrawals.

ENDOWMENTS_

An endowment fund is a powerful way to ensure your church or organization's mission thrives for generations. By preserving the principal and using the earnings to support vital ministries and long-term needs, endowments provide lasting financial stability. Establishing or contributing to an endowment is a meaningful act of stewardship—one that turns today's gifts into tomorrow's legacy.

WHAT IS AN ENDOWMENT?

A fund where the principal is preserved and earnings support your church's mission over time.

WHY CREATE AN ENDOWMENT?

To provide lasting financial stability and fund future ministry needs.

HOW DOES IT WORK?

Donors contribute; the fund is invested, and only the earnings are used for ministry.

WHO MANAGES THE ENDOWMENT

Typically, a committee oversees the fund, ensuring faithful and transparent stewardship.

FINANCING RESOURCES FOR GROWING CHURCHES

The United Methodist Foundation of North Carolina is committed to equipping churches and ministries with the resources they need to grow and thrive. Below, you'll find two trusted loan programs designed to support churches with construction, expansion, and renovation projects.

LOAN PROGRAM 1

The North Carolina Conference Board of Missions Loan Program

- Funding for new construction, major repairs, and land acquisition
- · Church-friendly loan terms and support
- Available to churches within the North Carolina Conference

LOAN PROGRAM 2

Western North Carolina United Methodist Foundation Loan Program

- Competitive interest rates
- · Loans for new construction, renovations, and refinancing
- · Designed specifically for United Methodist churches



STOCK GIFTS_

Donating appreciated stock is a powerful way to support the mission and ministries you care about. By contributing stock directly, you can make a meaningful impact while potentially enjoying significant tax benefits. HOW TO MAKE A STOCK GIFT

Complete the Memorandum of Intention: Before initiating a stock transfer, fill out the required form on our website. This ensures we can properly acknowledge your generous gift.

Initiate the Transfer: After submitting the form, you will receive instructions to provide to your broker to complete the transfer.

Confirmation and Acknowledgment: Once the transfer is complete, we will confirm receipt and provide you with an acknowledgment letter for your records.
